Mary Rice Hasson, J.D., is the Kate O'Beirne Senior Fellow at the Ethics and Public Policy Center in Washington, D.C., where she co-founded and directs the Person and Identity Project, an initiative that equips parents and faith-based institutions to promote the truth about the human person and counter gender ideology. Mary has been a keynote speaker for the Holy See during the United Nations Commission on the Status of Women, addressing education, women and work, caregiving, and gender ideology, and serves as a consultant to the U.S. Conference of Catholic Bishops' Committee on Laity, Marriage, Family, Life and Youth. She speaks frequently across the country, and has testified before the U.S. Senate, state legislatures, and the Australian parliament on parents' rights and transgender issues. The co-author of several books on education, Mary's writing has appeared in the Wall Street Journal, Newsweek, National Review, First Things, the National Catholic Register and Our Sunday Visitor, among others. In March 2023, Mary was the 2023 recipient of the Christifideles Laici award, presented at the National Catholic Prayer Breakfast. She is a graduate of the University of Notre Dame and Notre Dame Law School.

# **Archbishop Charles Scicluna**



His Grace Charles J. Scicluna was born in Toronto, Canada and moved to Qormi, Malta, in 1960 and to Lija, Malta, in 1976. After completing his Seminary studies and a Licentiate in Pastoral Theology at the Faculty of Theology, Tal-Virtù, he was ordained to the Roman Catholic priesthood by the Archbishop of Malta, Monsignor Joseph Mercieca, on July 11, 1986. Monsignor Scicluna was sent to read Canon Law at the Pontifical Gregorian University in Rome and obtained the doctorate in Canon Law with specialization in Jurisprudence in 1991. After his Rome studies he worked on the Malta Metropolitan Tribunal as Defender of the Bond and was lecturer in Pastoral Theology and Canon Law at the University of Malta. In addition to serving at various parishes, he also served as Vice Rector at the Major Seminary between 1994 and 1995 when he was called to the Vatican to work on the Supreme Tribunal of the Apostolic Segnatura as Substitute Promoter of Justice.

He was appointed Postulator for the cause of beatification and canonisation of Dun Ġorġ Preca, was nominated Promoter of Justice at the Congregation for the Doctrine of the Faith, has lectured widely on issues concerning child protection in the Church, helped with chaplaincy work at the Convent of the Nuns of Saint Bridget, Piazza Farnese, and as Extraordinary Confessor at the Venerable English College in Rome, is a Visiting Lecturer in Penal Processes at the Pontifical Gregorian University (Rome), was ordained Bishop in 2012, was nominated member of the Vatican's Congregation for the Doctrine of the Faith, was nominated as President of the Special College within the Congregation for the Doctrine of the Faith, and was appointed Bishop of Malta in 2015. In 2018, Pope Francis also appointed him as Adjunct Secretary of the Congregation for the Doctrine of the Faith of the Holy See.

## **Bishop Barry Knestout**



**Most Reverend Barry C. Knestout** is the 13<sup>th</sup> Bishop of the Diocese of Richmond. Appointed in 2017, he was installed in 2018.

He was ordained to the priesthood for the Archdiocese of Washington in 1989.

For five years, Father Knestout served as a parochial vicar at two parishes in the Archdiocese of Washington. In 1994, he was named priest-secretary to Cardinal Hickey and continued to serve in that capacity until His Eminence's death in 2004. It was during his tenure with Cardinal Hickey that in 1999 he received the Papal Honor of Chaplain to His Holiness, Pope John Paul II, with the title of Monsignor.

In October 2006 Monsignor Knestout was named Secretary for Pastoral Ministry and Social Concerns and was appointed Moderator of the Curia and Vicar for Administration of the Archdiocese of Washington in April 2007.

Pope Benedict XVI appointed him Auxiliary Bishop for the Archdiocese of Washington and Titular Bishop of Leavenworth in 2008. He selected "Christ Our Hope" as his episcopal motto. Bishop Knestout serves and has served on several national Catholic boards and committees including: Chair for the United States Conference of Catholic Bishops' Committee for the Protection of Children and Young People, Episcopal Advisory Committee for the Catholic Leadership Roundtable Board, Seminary Board of Directors at Mount Saint Mary's, Chairman of the Seminary Finance Board, Board of Directors for the Holy Family of Bethlehem Hospital Foundation, Regional Chairman for the bishops of Region IV until 2023, during which time he was also a member of the U.S.C.C.B. Subcommittee on the Church in Africa, and Subcommittee on African American Affairs, he was Episcopal Moderator for the Diocesan Fiscal Management Conference (DFMC) until 2024, is a Fourth-Degree member of the Knights of Columbus, member of the Order of Malta, and member of the Equestrian Order of the Holy Sepulchre of Jerusalem.

### **Michael Powers**



Michael Powers was one of three co-founders of Biometric Information Management (BIM) after serving in public sector government for thirty years. He was trained at the FBI where he was assigned to the Identification Division. He completed his Bachelor of Arts degree in Business Administration and a year later a Bachelor of Science degree in Information technology. He served over thirty years in the forensic field including crime scene technician, Systems Analysis for a local agencies Automated Fingerprint Identification System winding his public career as Deputy Director of Identification for the Ohio Attorney General's Bureau of Criminal Investigation. While serving as Deputy Director he was the Ohio compact officer for FBI CJIS Compact Council Officer, an agency responsible for policy and best practices for submitting fingerprint based background checks. He was also a member of the technology committee for Advisory Policy Board (APB) that makes policy recommendations for criminal justice agencies throughout the US. Awards during public service included Attorney General's excellence award and the Superintendents achievement award.

After retiring from the public sector, he co-founded BIM as a consulting company. Later the company moved toward fingerprint capture sales to law enforcement and civilian markets. BIM expanded from an equipment sales company creating a network for companies needing job applicants fingerprinted.

Fingerprint capture revenue now comprises 25 percent of BIM revenue and grew 60 percent in the last two years under his leadership. He is responsible for new business development through technology and services. New business in the last two years included software for Florida Clearinghouse, Client Hosted Solution/Biometric Information Management Solution (BIMS), and development of a new store-and-forward certifying these applications for use in state and federal markets.

# Callan Bryan



Callan Bryan is a highly experienced legal and compliance professional with over 14 years as the Chief Legal and Compliance Officer at bchex. In this role, he oversees compliance related to the Fair Credit Reporting Act, Equal Employment Opportunity Commission regulations, and other federal and state laws governing employment screening services. ## Cardinal Seán O'Malley



Cardinal Seán P. O'Malley, OFM Cap, was the ninth bishop and sixth archbishop in the more than 200-year history of the Archdiocese of Boston. Ordained to the priesthood in 1970 he also earned a Ph.D. in Spanish and Portuguese literature from The Catholic University of America, where he taught from 1969 to 1973. Upon leaving Catholic University, Cardinal O'Malley founded Centro Catolico Hispano (Hispanic Catholic Center), an organization that provides educational, medical, and legal help to immigrants. He was ordained a bishop in 1984 and named bishop of the Diocese of St. Thomas in the Virgin Islands in 1985. He was subsequently named bishop of the Diocese of Fall River, Mass., in 1992, and bishop of Palm Beach, Fla., in 2002.

In the summer of 2003 Bishop O'Malley was named Archbishop of Boston. He was created a cardinal by Pope Benedict XVI on March 24, 2006. Cardinal O'Malley is a member of the Administrative Board for the United States Conference of Catholic Bishops Committee and serves on the committees for Pro-Life Activities and for the Church in Latin America. Cardinal O'Malley presently serves on the Board of Trustees of The Catholic University of America. In 2013 Pope Francis appointed Cardinal O'Malley to the Council of Cardinals, in 2014 as President of the Pontifical Commission for the Protection of Minors and in 2017 to the Congregation for the Doctrine of the Faith.

On November 1, 2024, Cardinal O'Malley assumed the role of Archbishop Emeritus of the Archdiocese of Boston.
